### Scenario

Daniel is 17 years old. He works as a cashier at a dep near his home in Laval. He wants to save up to buy a car. He plans to use it mainly to drive to school and to visit his girlfriend in Ontario. After having saved \$1,900, he finds a used car for sale online. The selling price is \$1,550. Since he doesn't have any other expenses and has saved up enough money, he contacts the seller to say he is interested in buying the car. The seller tells him it's still available and that he can pick it up the next day. The seller doesn't know that Daniel is a minor.



Daniel goes to see the car. The seller tells him the car is in good condition and that it needs a few minor repairs. He also tells Daniel that the car was inspected last month. Daniel believes that the selling price of \$1,550 is still a good deal because the car is in good condition. The seller asks him to sign a document stating:

The buyer did not inspect the car at the time of purchase. He is buying the car "as seen and tested." He will make the necessary repairs. The seller is not responsible for any repair costs.





The car breaks down the second time Daniel drives it and needs to be towed. The cost of the repairs and towing is \$700. Daniel realizes the buyer took advantage of him and that he can't afford the repairs. He regrets his decision to buy the car and wasn't expecting all of these extra expenses. His parents are furious when they found out, even if they have the money to pay for the repair bills.
